Secretary-Treasurer's Report for CSSR 2014 AGM

John Moffatt was elected CSSR Secretary-Treasurer in June 2013 for a two-year term. Tania Smith, as previous Secretary-Treasurer and as Vice-President, continued to advise John in the S-T's role, and was instrumental in managing the society's MailChimp email account and in setting up our PayPal account.

Tania and Jeanie Wills continued to have signing authority for the CSSR's account. John was not added until spring 2014, due to an oversight/misunderstanding at the bank. Shannon Purves-Smith continues as signing authority as needed since CSSR cheques require 2 signatures.

Revenues 2013-2014

- CSSR saw another net gain in 2013-2014, of \$488.86, and once the PayPal revenues and other details are factored in, the figure for this period will be higher.
- We continued to receive EBSCO royalties for Rhetor journal online access through their databases. Revenues are distributed fairly evenly across both years at between \$200 and \$300 per year, and should rise as more journal articles become accessible via EBSCO.
- Revenue from T-Shirts continues to be negligible.

Expenses 2013-2014

- We offered a student paper prize again in 2013 (\$200).
- We have 4 years remaining on our 5-year \$100 domain renewal fee for cssr-scer.ca (due next in 2018). We will continue with our \$2.95/month web hosting contract with iPage until 2015. We continued to save money by using free software/services and having a volunteer webmaster.
- There is an unresolved controversy regarding fees from the 2013 conference in Victoria. We were billed for \$1177.05, and paid. However, early in 2014 Jeanie Wills identified a \$779.25 charge for a President's Banquet that we neither requested nor received. Queries to CanFed and UVic have thus far yielded no results, but the executive will continue to seek clarification/resolution on this issue, which would give us an additional gain of over \$700.

Paid Memberships

• 21 regular and 6 student members in 2013-14; 7/6 for 2014-15/16; the numbers will rise, as memberships are processed through the new PayPal process, and cash/cheque payments are counted after the 2014 conference.

Member / Subscriber Communication

• We have continued to manage our members' database and home page posts via email through our MailChimp account.
